

FROM THE DIRECTOR'S DESK



The primary pitch and narrative of the demonetisation drive by Prime Minister Narendra Modi seems to have taken a major shift to cashless economy from the initial key highlights of war against black money, corruption and counterfeit currency. That's the inference one can draw from the PM's Mann Ki Baat speech on Sunday.

"Our dream is that there should be a cashless society. This is correct that 100 percent cashless society is never possible. But we can make a start with less-cash society, then cashless society will not be a far-off destination," Modi said in the programme.

A significant part of the radio programme was devoted to the youth with the PM calling out to make the transition happen first to a 'less-cash economy' and a 'cashless' economy later. There was mention about black money, but the core of the talk was change to a cashless economy.

The PM urged people to start using cash substitutes like debit cards and digital wallets, saying it will make transactions cheaper and easier and in the long-term it will help India "leapfrog into a less cash-use economy at par with more developed nations."

"We are also urging banks to make a big push with PoS (Point of Sale) machines with traders so that debit card use becomes more prevalent," Modi said.

Interestingly, Reserve Bank of India (RBI) governor, Urjit Patel too shared his mann ki baat on the same day, after a stoic silence on the note ban and three weeks after the announcement.

In an interview to PTI, Patel urged people to start using cash substitutes like debit cards and digital wallets. The central bank governor said it will make transactions cheaper and easier and in the long term. It will help India "leapfrog into a less cash-use economy at par with more developed nations."

India will be registering a big progress if the Prime Minister's well-meaning more meets with even a qualified success.




Therefore amidst all this glory, we should not forget Chacha Nehru's real message. This day is a reminder to each one of us, to renew our commitment to the welfare of the children.

Top 10 business Opportunities in Hyderabad

Hyderabad is a major city of India that is always on heels. It is the capital of Telangana State and the temporary capital of Andhra Pradesh. There are lots of business opportunities in Hyderabad. Do you know it is not easy to start a business in this city? You need a business idea that is both unique and profitable. Hyderabad is a place where there are always a lot of businesses that open every day with unique concept. Now we take a look at top 10 business ideas and opportunities that can be explored in Hyderabad. Students interested in venturing in to these businesses are advised to do lot of preparatory work before moving further.

1. Food delivery business

*(Investment –Rs. 15,000 – 25,000 *Return on Investment(ROI) – 6 months to 10 months)

Not all hotels provide home delivery services. At the same time, customers might want best food items from the best restaurants at the same time. This is not possible with the current home delivery services. This is where your business starts. You get orders from the clients, send your helper boys to those hotels and deliver the requested food items to your clients. You need not have an infrastructure or inventory for this business. You would need a team of helper boys, internet connection, phone connection and an assistant to attend calls for you, if needed.

2. Tank cleaning business

*(Investment –Rs 1, 00,000 to 1,50,000 *ROI – 4 to 7 months)

Tank cleaning might look like a simple business or an unskilled labour. Today, there are no adequate workers who can provide safe cleaning solution for water tanks. Your initial investment includes appropriate equipment, cleaning agents and a few helper boys (if needed). You can start the business for residential areas initially and then focus on commercial and industrial areas.

3. Online advertisement agency

*(Investment –Rs 1, 00,000 to 3, 00,000 *ROI – 1 year to 3 years)

Do you have a working knowledge of online advertisement, PPC and online campaigns? If so, you can start your own digital advertising company. There are very few companies in Hyderabad in this genre. The initial investment includes, cost of rental space, equipment like computer, internet connection, telephone connection and others, salary for human resource, advertisement, website and so on. Your business motto is to help your clients advertise their business in search engine and gain more traffic to their sites.

4. Travel agency

*(Investment – Rs 50,000 to 75,000 *ROI – 1 year to 3 years)

Hyderabad is one of the many places in India where many tourists visit every year. Starting from wildlife safari to sightseeing, tourists search for professional tour guides who arrange vehicles, plan their trip and also provide exciting information about each site. It is a very complex service. You need to control all aspects of the tour starting from booking hotels based on preference of your client to providing information about all tourism destinations. The initial investment includes equipment like binoculars, camping equipment and so on, a few human resource and a website.

5. Pet care services

*(Investment – Rs 1, 00,000 to 5, 00,000 *ROI – 1 year to 2 years)

A lot of pet owners are looking for a service where they can leave their pet, while they go on a vacation. During that time period, you need to take care of feeding, walking, grooming and others. Apart from pet care service, you can also provide other services for regular clients like grooming, de-worming and so on. The scope of business ideas related to pet care is very high. Hygiene is very essential. The initial investment includes human resource, equipment, caging spaces, toys, commercial space, pet care products and so on. A website is an added advantage.

6. Relocation services

*(Investment –Rs 1, 00,000 to 2, 00,000 *ROI – 8 months to one year)

There are a very few movers and packers in Hyderabad. People settle with semi-skilled labours for this process. If you can provide a cost effective service for moving and relocating, you can catch the market. You can also provide other value added services like temporary storage arrangements for those who plan on remodeling or cleaning their new house before relocating. Startup capital is required for buying trucks, package materials, human resource, commercial space, internet connection, computer and phone connection.

7. Event management

*(Investment – less than Rs 10,000 *ROI- one year)

Hyderabad is always in party mood. Starting from formal corporate parties to weddings, people are looking for efficient event managers. Do you have a strong network of caterers, decorators, chairs and other seating arrangement rentals, music orchestra, housekeeping services etc? You can start a profitable event management services. The capital required is very less as the finances would be handled by the host. You would need an internet connection, computer, phone connection and a strong network. Your success in this business depends on your networking skills and the speed of business idea's growth depends on the type of projects you get.

8. Errand service

*(Investment – less thanRs 10,000 *ROI- 6 to 7 months)

Starting from dry cleaning to post office, there are a lot of services that do not provide home delivery. In the hustle of today's life, people in Hyderabad are looking for efficient people who can run errands for them. You would not need a large startup capital as all that you need is a small vehicle and a few helper boys. Starting from hunting for gifts to picking up dry cleaning, these helper boys should provide required services to your clients. The growth might take time as this is one of new business ideas in Hyderabad and acquiring clients would be hard. Even if you are able to satisfy one customer, you can increase your customer base through positive word of mouth.

9. Competitive exam coaching center

*(Investment –Rs 40,000 to 60,000 *ROI – 10 months to one year) Starting from UPSC to AIEEE, there are a lot of competitive exams which are attended by students for post graduation and for jobs. You can start a business by hiring a few instructors who can teach the students for these exams. Syllabus for each exam is different and thus, you might need three to four instructors for one examination. It is better to focus on one examination for increasing business opportunities in Hyderabad. Your initial expense includes hiring instructors, leasing seating arrangement, rental space, blackboard, printed study materials and other stationery and advertisements.

10. Vehicle rental service

*(Investment -Rs 1, 00,000 to 3, 00,000 *ROI-one year)

Taxi and rental car service businesses are at peak in the city. Your business model is to get profit by renting cars to taxi drivers and the rental car services. There are a lot of rental car services that do not employ more money in vehicles and tend to lease them. You can create an inventory of used cars of various models and rent them to companies and individuals. If you can spend more money, you can focus on trucks and small commercial vehicles which would yield more profit.

These are some of the top business ideas for Hyderabad market. If you could create a good network and acquire a few loyal customers, you can break even faster. Jayalalithaa: The Amma of Tamilnadu

Jayalalithaa Jayaram, popularly known as Jayalalithaa, was born on 24 February 1948. She was an Indian actor turned politician who hadserved five terms as the Chief Minister of Tamil Nadu, for over fourteen years between 1991 and 2016. She ruled over the tinsel world and the world of politics and breathed her last recently leaving a big void which cannot be filled by any of her followers in AIDMK. This piece is written to highlight and assess her life and achievements as a doyen in the public life of Tamils.

Childhood:

Jayalalithaa was born on 24 February 1948 at Melukote in old Mysore State (now Karnataka) to Jayaram and Vedavalli in a Tamil Iyengar- family. Jayalalithaa was given her grandmother's name Koamalavalli at the time of birth. As per lyengar Brahmin's custom, two names are given to a newborn girls - one ancestral grandmother's name and the other the personal name. Her paternal grandfather, Narasimhan Rengachary, was in the service of the State of Mysore as a surgeon and the court physician to Maharaja Krishna Raja Wadiyar IV . Her maternal grandfather, Rangasamy lyengar, had moved to Mysore from Srirangam to work with Hindustan Aeronautics Limited. He had one son and three daughters – Ambujavalli, Vedavalli(Jayalalithaa's mother) and Padmavalli. Vedavalli was given in marriage to Narasimhan Rengachary's son, Jayaram. The Jayaram-Vedvalli couple had two children: a son Jayakumar and a daughter, Jayalalithaa. Jayalalithaa's mother, relatives, later co-stars and friends used her as Ammu.

Jayalalithaa moved to Madras along with her mother after her father's death. She completed her education at Sacred Heart Matriculation School, popularly known as Church Park Presentation Convent or Presentation Church Park Convent. She excelled at school and was offered a government scholarship to pursue further studies. She won Gold State Award for coming first at the 10th Standard Public Examinations in the State of Tamil Nadu. She appears not to have accepted the admission offer from Stella Maris College.She was fluent in several languages, including Tamil, Telugu, Kannada, Hindi, Malayalam and English.

Her brother Jayakumar's wife Vijayalakshmi and his daughter Deepa live in T.Nagar Chennai. Her brother died in 1995 in an accident. She remained unmarried.

Film Career:

Jayalalithaa was a populour actress of yester-years. She played female lead roles in scores of films in Tamil, Telugu, Kannada, Malayalam and Hindi. She had acted with all most all the popular heroes of the South Indian cinema. Many of her films were boxoffice hits. She had left the film field in the prime of her career to join politics at the behest of her mentor late MGRamachandran (MGR)in 1982.

Political Life:

Early political career: Jayalalithaa claims that MGR, who had been Chief Minister for the State of Tamilnadu since 1977, was instrumental in introducing her to politics. In 1982, she joined the AIADMK, which was founded by MGR. Her maiden and successful public speech, "Pennin Perumai" (meaning the greatness of a woman), was delivered at the AIADMK's political conference in the same year. In 1983, she became the Propaganda Secretary of the AIDMK Party and was selected as its candidate in the bye-election to the Tiruchendur Assembly Constituency.

MGR wanted her to be a member of the Rajya Sabha because of her excellent command over English. She was nominated and elected to that body in 1984 and retained her seat until 1989. Her success in her role as Propaganda Secretary of the party caused resentment among high-ranking members of that party. By engineering a rift between her and MGR, these members influenced MGR to stop her writing about her personal life in a Tamil magazine. Despite these machinations, she continued to be admired by the rank and file of the party.

In 1984, when MGR was incapacitated due to a

stroke, Jayalalithaa was said to have attempted to take over the position of Chief Minister or the party on the pretext that his health would prevent him from the proper execution of his duties in two very demanding roles. She successfully led the campaign in the 1984 General Elections, in which the ADMK allied with the Congress. Following the death of MGR, three years later, the AIADMK split into two factions: one of which supported his widow, Janaki Ramachandran, and the other favoured Jayalalithaa. Janaki was elected as the Chief Minister on 7th of January 1988 with the support of 96 members; due in part to irregularities by speaker P.H. Pandian, who dismissed six members to ease her victory. She had won a motion of confidence in the house. However, Rajiv Gandhi used Article 356 of the Constitution of India to dismiss the Janaki-led government and impose President's Rule on the state of Tamilnadu.

Jayalalithaa contested the subsequent 1989 elections on the basis of being MGR's political heir.

Leader of the Opposition, 1989: She was elected to the Tamil Nadu Legislative Assembly in 1989 as a representative of the Bodinayakkanur State Assembly Constituency. This election saw the Jayalalithaa-led faction of the AIADMK win 27 seats and Jayalalithaa became the first woman to be elected Leader of the Opposition of Tamilnadu. In February 1989, the two factions of ADMK merged and unanimously accepted Jayalalithaa as their leader and the "Two leaves" symbol of the party was restored.

First term as Chief Minister, 1991: In 1991, following the assassination of Rajiv Gandhi days before the elections, her alliance with the Indian National Congress enabled her to ride the wave of sympathy that gave the coalition a victory. The ADMK alliance with the Congress won 225 out of the 234 seats contested and won all 39 Parliamentary Constituencies from Tamilnadu. Re-elected to the assembly, she became the youngest and the first female, Chief Minister of Tamil Nadu.She served a full term of five years in this seat, serving from 24 June 1991 to 12 May 1996.

Loss of power in 1996: The Jayalalithaa-led AIADMK lost power in the 1996 elections, when it won only four of the 168 seats that it contested. Jayalalithaa was herself defeated by the DMK rival in Bargur Constituency. The outcome has been attributed to an anti-incumbency sentiment and several allegations of corruption and malfeasance against her and her ministers. The wedding event of her foster son Sudhakaran, who married a granddaughter of the Tamil film actor Shivaji Ganesan, was held on 7 September 1995 at Chennai and was viewed on large screens by over 150,000 people. The event holds two Guinness World Records: one is for the most guests at a wedding and the other is for being the largest wedding banquet. Subsequently, in November 2011, Jayalalithaa told a special court than the entire Rs. 6 Crore expenses associated with the wedding were paid by the family of the bride. There were several corruption cases filed against her by the then ruling DMK Government headed by Karunanidhi.

Police arrest and custody: Jayalalithaa was arrested on 7th December 1996 and was remanded to a 30day judicial custody in connection with theColour TV scam, which charged her with receiving kickbacks to the tune of Rs 10.13 crore. The investigation alleged that the amount through the TV dealers were routed in the form of cheques to a relative of her best friend Sasikala who had quoted Jayalalitha's residence as hers. She earlier filed an anticipatory bail in the trial court, which was rejected on 7 December 1996. She was however acquitted in the case on 30 May 2000 by the trial court. The High Court too had upheld the order of the lower court.

Second term as Chief Minister, 2001: Jayalalithaa was barred from contesting as a candidate in the 2001 elections because she was found guilty of criminal offences, including allegedly obtaining property belonging to a state-operated agency called TANSI. Although she appealed to the Supreme Court, having been sentenced to five years' imprisonment, the matter was not resolved at the time of the elections. Despite this, the AIADMK had won a majority and she was installed as Chief Minister as a non-elected member of the state assembly on 14 May 2001. She was also convicted with one year prison term in the Pleasant Stay hotel case on 3 February 2000 by a trial court. Jayalalithaa was acquitted in both the TANSI and Pleasant Stay Hotel cases on 4 December 2001 and the Supreme Court upheld the order of the High Court on 24 November 2003.

Her appointment was however legally voided in September 2001 when the Supreme Court ruled that she could not hold it whilst convicted of criminal acts. O. Panneerselvam, a minister in her party, was subsequently installed as the Chief Minister. However, his government was purported to have been puppeted and micro-managed by Jayalalithaa.

Third term as Chief Minister, 2011: In April 2011, the AIADMK was part of a 13-party alliance that won the 14th State Essembly Elections. Jayalalithaa was sworn in as the Chief Minister of Tamil Nadu for the third time on 16 May 2011, having been elected unanimously as the leader of the AIADMK party subsequent to those elections. On 19 December 2011, Jayalalithaa expelled her long-time close aide Sasikala Natarajan and 13 others from the AIADMK. Most of the party members welcomed her decision, and on 2 February 2012, the Tehelka magazine claimed that Natarajan and some of her relatives were conspiring to kill her by poisoning her food over a period of time. The matter was resolved by 31 March, when Sasikala Natarajan was reinstated as a party member after submitting a written apology.

Disproportionate Assets case, 2014: On 27 September 2014, Jayalalithaa was sentenced to four years in jail and fined Rs 100 crore by the Special Court in Bangalore. She was convicted in an 18-yearold disproportionate assets case that was launched by Janata Party President Subramanian Swamy (now member of Bharatiya Janata Party) on 20 August 1996 on the basis of an Income Tax Department report on her. Jayalalithaa's close aide Sasikala Natarajan, her niece Ilavarasi, her nephew and the Chief Minister's disowned foster son Sudhakaran were also convicted. They were sentenced to four years in jail and fined Rs 10 crores each. Special Judge John Michael D'Cunha convicted due to her owning assets to the tune of Rs 66.65 crores (which includes 2,000 acres of land, 30 kg of gold and 12,000 saris)

disproportionate to her known sources of income during 1991–96 when she was Chief Minister for the first time. The verdict was delivered by a makeshift court in the Parappana Agrahara prison complex in the presence of Jayalalithaa and the other accused. She was automatically disqualified from the post of CM and the Legislative aAssembly of Tamil Nadu.She was the first Indian Chief Minister to be disqualified. O. Panneerselvam, a minister in her party, succeeded her as the Chief Minister on 29 September 2014. On 17 October 2014, the Supreme Court granted her two months' bail and suspended her sentence

Return as Chief Minister, 2015: The acquittal allowed her once again to hold the coveted office of Chief Minister's office. On the 23rd of May 2015, Jayalalithaa was sworn in as Chief Minister of Tamil Nadu for a fifth time. She was subsequently re-elected by the electorate of the Dr. Radhakrishnan Nagar State Assembly Constituency of North Chennai in the byelection held on 27 June 2015. In a landslide victory, she polled more than 88 per cent votes of the 74.4 per cent turnout, winning by a margin of over 1.6 lakh votes.

Elected as Chief Minister in 2016: Jayalalithaa was again elected as the Chief Minister of Tamil Nadu after the May 2016 elections. She was the second Chief Minister, after MGR, to serve consecutive terms as Chief Minister. Awards and Honours:

In 1972, Jayalalithaa was presented the Kalaimamani Award by the Government of Tamil Nadu. She has received several honorary doctorates and other honours, beginning with an award from the University of Madras in 1991. Death:

On 22 September 2016, Jayalalithaa was admitted to Apollo Hospitals in Chennai, as she suffered from infection and acute dehydration. O. Panneerselvam was sworn in as Chief Minister on 12 October. She was also said to be suffering from severe pulmonary infection and septicaemia, which were cured. On December 4, she was re-admitted to the critical care unit after suffering a cardiac arrest. The hospital released a press statement stating that her condition was "very critical" and that she was on life support. On December 5, the hospital officially announced the death of the Chief Minister at 23:30 IST. The Central Government declared a one day national mourning with the national flag in all government buildings flying at half-mast, while the State of Tamil Nadu declared seven days of mourning. Her body was kept for public viewing at her residence in Poes Garden and Rajaji Hall. Her last rites were performed at 18:30 IST on 6 December 2016 and she was interred in the northern end of the Marina beach in Chennai, near the grave of her mentor late M.G. Ramachandran. Her funeral procession was one of the biggest Tamil Nadu ever witnessed, after those of C. N. Annadurai, MGR and Sivaji Ganesan. Thousands attended her funeral and paid their final respects.

An Assessment:

Jayalalithaa, 'amma' to her a legion of fan followers, 'ammu' to her kith and kin and "purachi talaivi" to people to whom she was a benefactor has demitted the public space of Tamil Nadu's political firmament after dominating it for about a quarter century. She ruled over the hearts and minds of millions of Tamils. She was one of the most charismatic as well as controversial figures of post-Independent Tamil Nadu. Her heart-broken admirers died in hundreds after hearing that their leader was no more. She has perfected the fine art of populism and doled out many schemes for the poor and the indigent and saw to it that they feel benefitted substantially from out of them. At the same time her critics and political rivals accuse her for the personality cult she nurtured by abetting and encouraging the 'paada pooja' or prostration at her feet. She is also faulted for indulging in an overtly extravagant life style She has contributed substantially for the industrial development of the State of Tamil Nadu. She alternated in power with her arch rival Karunanidhi. She went through ups and downs in her life but she retained her poise and fighting skills till her death. She donned the mantles of party and government. She has demonstrated to women how they can dominate the male-dominated world of power politics at their own terms. The void created in Tamil Nadu by her death at 68 is a difficult one to fill.
