





#### HOW OBAMA'S WIN GOING TO AFFECT IP IN INDIA

"Our economy is recovering. A decade of war is ending. A long campaign is now over. And whether I earned your vote or not, I have listened to you, I have learned from you, and you've made me a better President. And with your stories and your struggles, I return to the White House more determined and more inspired than ever about the work there is to do and the future that lies ahead." said Barack Obama who won the United States Presidential Election for 2012 and now, he will be in power for next four years.

The next question that is to be answered is that how this is important for Indians and what impact will it have on India? Neither of the two candidates spelled out their views in detail during their campaign. So will there be an approach similar to the one followed by the President in his first term or will the second term bring about a change.

Barack Obama's return as US President is sparking optimism and confidence among Americans but his second innings at the White House has made Indian IT-BPO players edgy and cautious over a possible backlash on outsourcing as a business model, which provides opportunities for Indian firms. First, outsourcing regime is keenly followed by India and Obama's policies have been conservative on this. He wants to stop outsourcing so that more job opportunities are created for Americans. To do this visa policies have been tightened and even taxes have been increased on giant firms who are involved in outsourcing. According to a study carried out by US Bureau of Economic Analysis, American companies have hired fewer people domestically as compared to people hired abroad through outsourcing. This creates a lot of job opportunities for Indians in IPR sector, and if they work proficiently and with will they can even find a place in US for themselves. Apart from drafting, patent agents in India are also helping patent prosecutors in America to prove patents invalid or valid by carrying out the work allotted to them.

Barack Obama had said that he will be spending around \$15 billion every year to create jobs for Americans, and if that happens than outsourcing will stop and that will mean lesser jobs for patent agents of India in US patent system. On one hand Barack Obama is trying to take America onto new heights and on the other side he is pulling back America back to start. Outsourcing and AIA are the two feathers in President Obama's cap but in spite of telling Americans that more jobs will be created in America, a lot of funding has been done to other nations by American government that have only created jobs in other nations and not in America. Stopping outsourcing will have a bad impact on IPR sector in India and will lead to unemployment and will also increase the cost company spend on employs if only Americans are allowed to work on IP, Indian companies offer the same service at a very low price as compared to their counterparts all around the world. That is why it would be too hard for Barack Obama to implement ban on outsourcing in IPR, not only in IPR but in other sectors as well.

### World Aids Day - 1<sup>st</sup> December

The United Nations' World AIDS Day, celebrated on 1st December every year is an opportunity for people worldwide to unite in the fight against HIV, show their support for people living with HIV and to commemorate people who have died. World AIDS Day was the first ever global health day and the first one was held in 1988. 30 years after the first cases of HIV – the red ribbon is the universal symbol of awareness and



support for those living with HIV. The red ribbon was the first ever ribbon symbol, inspiring the several other later versions.

An estimated 34 million people globally are currently living with HIV. More than 25 million people between 1981 and 2007 have died from the virus, making it one of the most destructive pandemics in history. Today, many scientific advances have been made in HIV treatment, there are laws to protect people living with HIV and we understand so much more about the condition. But despite this, people do not know the facts about how to protect themselves and others from HIV, and stigma and discrimination remain a reality for many people living with HIV. World AIDS Day is important as it reminds the public and Government that HIV has not gone away – there is still a vital need to raise money, increase awareness, fight prejudice and improve education.

## Indian Navy Day - 4<sup>th</sup> December

4th December, 1971 was the day when the Indian Navy played a

significant role in the bombing of Karachi harbor in the 1971 war. The name given to the attack was Operation Trident which was launched on December 4. Owing to its success, the day of the attack has been celebrated as Navy Day ever since. The theme of Navy day




celebrations this year will be 'Safe Seas and Secure Coasts for a strong Nation'.

# Jamba Cloud Hyderabad 10K Run

## Unique platform to raise money for charity

The 10th edition of Jamba Cloud Hyderabad 10K Run, was held in Hyderabad on November 25, 2012 at People's Plaza, Necklace Road .The 10K run is accompanied by 7K Mazza Run where in the students of Aurora Business School helped the charity partner United Way of Hyderabad and Procam International in organizing the event .



# **Leaders Are Born and Not Made**



Inder Kumar Gujral

December 1919 - November 2012

Inder Kumar Gujral, who served as the Prime Minister in United Front government in 1990s, died at the age of 92 on 30 November 2012. He became the 13th Prime Minister of India on 21 April 1997 and held that post till 19 March 1998 in United Front government, after the resignation of HD Deve Gowda. He belonged to Janta Dal party. Gujral was a Rajya Sabha Member twice from 1964 to 1976 and a member of the Lok Sabha from 1989 to 1991. He was re-elected to Lok Sabha from Jalandhar in Punjab as an independent with help from Akali Dal in 1998. It is important to note that he was the Rajya Sabha member during his tenure as the Indian Prime Minister. He had written *Matters of Discretion: An Autobiography* which was released in February 2011. It was during his tenure as the Prime Minister that the Golden Jubilee (50 years) Of Indian Independence was celebrated.

#### HIS LIFE:

- He was born on 4 December 1919 in Jhelum (Pakistan's Punjab Province). He belonged to a family of freedom fighters.
- He began his political career with the Quit India movement in 1942.
- $\bullet \quad \text{He left Congress and joined Janata Dal in late 1980s}.$
- He retired from active politics in 1999.
- His wife, Sheila was a poet and author. She died in 2011. His brother Satish Gujral is a prominent painter. Ik Gujral's son Naresh Gujral is a Rajya Sabha MP and an Akali Dal leader.
